A NEW PARTNERSHIP TO ENGAGE FORMER SENIOR EXECUTIVES TO EMBARK ON A VOLUNTEERING JOURNEY IN THE SOCIAL SERVICE SECTOR

Singapore, 8 May 2019 – Former senior executives from financial services now have another way to contribute to society upon retirement.

2 A new partnership has been forged between a non-profit organisation and a social enterprise to engage former senior executives to embark on a volunteering journey in the social service sector. The partnership will be signed between RSVP Singapore The Organisation of Senior Volunteers, a National Centre of Excellence for Senior Volunteerism, and Singapore Consultancy, a social enterprise that converts senior financial services industry practitioners into management consultants and board directors.

3 This three-year partnership will engage 50 senior executives by developing them through volunteer learning, exposing them to both on-the-ground volunteering, and skills-based volunteering experiences. It will also provide multiple avenues for these executives to give back to the community using their skill sets and experience.

4 Mr Koh Juay Meng, Chairman of RSVP Singapore, said, “As the National Centre of Excellence for Senior Volunteerism, we are committed to fulfilling our vision of making every senior a volunteer. This new partnership with Singapore Consultancy gives us an opportunity to engage former senior executives from the financial services industry as volunteers to give back to the community using their skills and experience.”

5 Mr Steven Seow, Executive Director of Singapore Consultancy said, ““At Singapore Consultancy, we are very excited about this partnership with RSVP. We believe that people will find happiness when they able to do the things that they are good in, that they love and that the world needs. The combined eco system between Singapore Consultancy and RSVP will help our members to achieve this. It’s an excellent symbiotic relationship.”

6 RSVP Singapore was started in 1998 with the objective of developing senior volunteers and empowering them to share and serve the community. The organisation currently has 2,500 volunteers serving its regular and ad-hoc programmes.
